## W. Randall F. Seller awarded Law Society Medal

In the 38 years since it was offered, the Law Society Medal has only been awarded to 232 lawyers. For 45 years, he has consistently given of his time, creativity and expertise to improve the lives of those in our community, both as their legal counsel and through his extensive personal volunteerism.

We were honoured to be able to attend with Randy in Toronto, with our retired partner, E. James ("Jim") Hook, and congratulate Randy on this outstanding recognition.





## **Will Search Requests**


The project is taking a bit longer than first anticipated, as I have been conducting inventory, and making entries in a circulation database as I go.


