

Message from the KDLA Executive

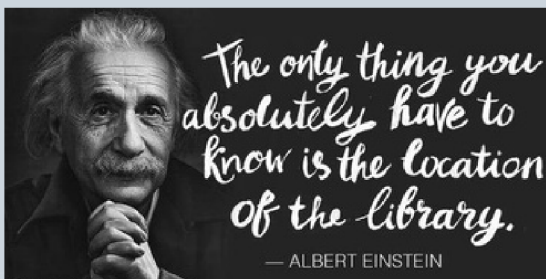
